Circular

Subject: - Eligibility for appearing in the Revenue Audit Examination.

1 In the revamped scheme of Subordinate Audit Examination (SAS), a candidate can appear in both the groups (I & II) of SAS examination simultaneously. Further it has also been decided to conduct SAS Examination twice in a year i.e. SAS main examination and SAS supplementary examination.

2 Accordingly, the eligibility criteria for appearing in the Revenue Audit Examination have been reviewed and the existing provisions in para 9.3 of the C & AG's MSO (Admn.), Vol. I, governing the eligibility criteria for appearing in the Revenue Audit Examination have been amended by the Competent Authority as mentioned below:

- (i) Departmental officials who are promoted as AAO are eligible to appear in Revenue Audit Examination after completion of one year of continuous service in Revenue Audit Branch; or have the prescribed training in Revenue Audit after completion of one year of continuous service as AAO.
- (ii) Confirmed Directly Recruited AAOs are eligible to appear in Revenue Audit Examination after completion of one year of regular service in Revenue Audit Branch as a regular AAO; or have the prescribed training in Revenue Audit after completion of one year of regular service after confirmation as AAO.

3 The aforesaid eligibility criteria for appearing in Revenue Audit Examination would be applicable from Revenue Audit Exam 2012.




